Dear CECOP members,

The 2021 CECOP Report of Activity is still marked by the consequences of the crisis caused by the pandemic, but also by a strong continuation of our organization's activities to promote and enhance the work of cooperatives, in key areas of the daily lives of many European citizens. At the same time, our work in strategic

sectors of the economy, industry, and social infrastructure, has continued in all communities where our cooperatives operate.

We have done this with commitment and dedication, turning the need to work remotely through digital devices into a new opportunity to be closer to our members, closer to cooperatives, and better connected. We have also remained active in international relations with CICOPA, the ICA, and with our European partners: Social Economy Europe, Social Platform, and Cooperatives Europe.

Concerning our advocacy work, the most challenging themes have been, on one side, the intense preparatory work for the launch in December 2021 of the Social Economy Action Plan by the European Commission, and on the other hand, the engagement with the European Industrial Forum, whose topics are key for many of our cooperatives.

Interlacing the industrial and the social paths is the issue of platform cooperatives and digital platform workers, the subject of a directive that the European Commission published in December last year. We have been working hard in the preparatory phase, and we continue working hard to keep the voices of our cooperatives heard during the process, leading to a legislative transformation.

In the pages of this report, you will find information that gives an overview of the work we have done, which I invite you to read and explore further.

As we are writing these pages on the activity of the past year, we cannot avoid thinking of the current, unacceptable, and incomprehensible war that is raging in the heart of the Europe we love.

The distress and the violence affecting the people of Ukraine is worrying.

Cooperatives are enterprises for peace and solidarity. Many of our cooperatives in the neighboring countries are working to welcome people forced to leave their homes. As well as in all the other countries where our members are present, we know that solidarity initiatives are numerous and are a credit to the cooperative movement.

As a representative organization, we shall be aware of the very difficult times ahead of us, humanly and economically. That is why we have, once again, to bring out the capabilities and potential of cooperatives, in promoting a different model of development and economy: inclusive, democratic, participatory, and fair.

Dear CECOP members,

2021 was a remarkable year. While the world was still amid the COVID-19 pandemic, some parts of the European continent started to see the light at the end of the tunnel. Many of our members, and their cooperatives, were also able to start recovering and re-establishing operations after some intermittent pauses. For CECOP, it was no

exception. The year also came with its challenges and setbacks, as for some months, the staff were confined to their homes, but our work had to continue.

Our activities were diverse from the start. In the first semester, CECOP organised a joint conference together with our Portuguese member Confecoop, in which we discussed the future of the EU disability strategy. In the second semester, we published "Lights On!", our modest but important contribution on how worker and social cooperatives tackle informal work, starting off from examples of our network.

We continued a work started in 2018 on cooperatives' social impact measurement in collaboration with our members through a mutual learning session organized in July and a publication, "Lasting Impact", shedding the light on experiences from Italy and Spain.

At the same time, our Vice-President, Francesca Montalti, has been appointed as member of the EU Industrial Forum, which comes as an important recognition of cooperatives as an integral part of the European industrial landscape.

The end of the year saw two highly awaited policy files that had been in the making and on our table for quite some time: the Social Economy Action Plan, and the Platform Work Directive. The CECOP secretariat followed and discussed with members these files closely for years and started developing relevant policies that will benefit the cooperatives from our network.

CECOP also had its fair share of democratic elections, the nomination of a new Board and the re-election of our President, Giuseppe Guerini. After a co-construction process with members, we also unveiled our new strategic plan for the next four years (2021-2025), which will serve as a compass to continue our important work, giving our members and their cooperatives visibility in the EU, as well as providing them with the tools and resources to continue developing and strengthening. Finally, we also had the pleasure to welcome a new member from Slovenia.

Moreover, 2021 was the last year of our four-year partnership agreement with the European Commission under the EaSI programme. This partnership benefited CECOP tremendously, enhancing our presence and our advocacy work within the European institutions, contributing to the capacity building of our network, increasing the opportunities for collaboration with partners, and reinforcing our mutual relationship with members.

I am also pleased to announce that at the end of the year, we signed a new four-year partnership agreement (2021-2024) under the ESF+ programme. This is not only a re-confirmation of our established relationship with the European Commission, but it will also provide us with the additional resources necessary to continue contributing to the implementation of the European Pillar of Social Rights.

All those impressive achievements would not have been possible without the energy and commitment invested by my colleagues, and I would like personally to thank Francesca Zaganelli, Mila Shamku, Victoria Hernandez, Anton Möller, and Diana Potjomkina. And of course, our President, Board members and all CECOP members for their support.

We look forward to sharing with you our activities and work throughout the year.

New Strategic Plan 2021 – 2025

In June 2021, CECOP members approved the new CECOP Strategic Plan for 2021 – 2025 which consists mainly of three pillars:

- First pillar: To ensure that EU policies and legislation create a favorable environment for worker and social cooperatives
- Second pillar: To increase the visibility for worker and social cooperatives in Europe
- Third pillar: To build a strong and democratically-led network

As the world is still recovering from the COVID-19 pandemic and crisis, its impact on cooperatives continues to pose a struggle. Other challenges such as the green and digital transition for cooperatives, their access to capital, and youth engagement, will shape the actions of our organization in the next years. Additionally, the rise in non-standard employment and the ascension of platform cooperatives will also demand attention and specific actions in the future.


New Board 2021 - 2025

During 2021, two working groups were active: The Working Group on Platform Work, tasked with discussing non-standard and platform work, and the Working Group on Industry – reacting with some concrete recommendations on the European Commission's Industry Strategy.

CECOP worked in partnership with the Commission and with the partners to bring worker and social cooperatives into the center of the discussion, acknowledging them as a key social economy actor and making sure they fully benefit from the proposed measures.

Action Plan for the European Pillar of Social Rights

In 2021, CECOP <u>welcomed</u> the European Commission's Action Plan to implement the European Pillar of Social Rights proclaimed in 2017. Rightfully, this action plan acknowledges the potential of social economy actors such as worker and social cooperatives in delivering these social rights to European citizens. CECOP closely follows – notably through its EaSI grant agreement – the implementation of the Action Plan to make sure that promises are kept.



"Stand Up for the Social Pillar" Alliance

Together with Social Platform, European Trade Union Confederation, Social Economy Europe, and European Movement International, we are part of the "Stand Up for the Social Pillar" Alliance, calling on the European Institutions and Member States to properly implement the 20 principles of the European Pillar of Social Rights. In 2021, the Alliance signed a joint statement for the implementation of the Action Plan and was part of "A solidarity Action Plan for All" event.



CECOP at the high-level conference on Social Economy of the Portuguese EU Presidency

The role of cooperatives in <u>creating local jobs and tailored services for their communities</u> was highlighted by our President during the High-level conference on Social Economy of the Portuguese EU Presidency.



CECOP Lasting Impact report

<u>Lasting Impact report</u>: In this report, two well-established measurement tools in Italy and Spain show the importance of collecting data on the social impact of cooperatives in their communities — not just to increase their visibility but also to self-assess their work.



CECOP at EESC Public Hearing on social economy and recovery

During a public hearing of the European Economic and Social Committee, CECOP President Guerini and several members of CECOP discussed the role of the social economy in a fair and sustainable recovery of Europe's economy. 'The Social Economy is a key partner in the recovery from the COVID-19 pandemic, to ensure inclusive growth and job creation, and to implement the European Pillar of Social Rights', said CECOP President. Cooperatives at the center of the new European Industrial Strategy

Most of the cooperatives represented by CECOP are SMEs (almost 90%), and around 40% are active in the industry sector. The current business landscape is a demanding one, as the industry must adapt to the new needs of the constantly changing market. CECOP continues to bring forth the voice of cooperatives working in industry as an example of resilience, democracy, sustainability and innovation. In particular, it highlights the importance of supporting cooperatives for a just and democratic transition in the implementation of the EU Industry and SME Strategy approved by the European Commission in March 2020.



CECOP at the European Industrial Forum

CECOP is represented by its <u>Vice-President Francesca Montalti</u> in the European Industrial Forum and active in three of its Task Forces: Task Force 1 - Single Market, KPIs and industrial ecosystems; Task Force 2 - Support the development of transition pathways; Task Force 4 - Identify and advise on cross-border and cross-ecosystem investment needs and cooperation opportunities. It monitors the implementation of the Industrial Strategy and provides input to the Commission's Annual Single Market Reports.



Industrial Strategy lacking recognition of worker and social cooperatives' resilience

The Industrial Strategy does not acknowledge the importance of worker and social cooperatives to create and maintain jobs, especially in critical times. CE-COP has thus drawn some key lessons learned during the recent COVID-19 crisis and the impact on its cooperatives.



CECOP in the Focus Group on Pact for Skills

In the context of the <u>Pact for Skills</u>, launched by the European Commission, CECOP joined a Focus Group launched by DG GROW to contribute to the promotion of concrete actions to support the upskilling and reskilling of workers in Europe.



CECOP at the EU Industry Days

The EU Industry Days is an event organized annually by the European Commission to discuss industry challenges and co-develop opportunities and policy responses in an inclusive dialogue with a wide range of stakeholders. In 2021, CECOP spoke in the panel organized by Mondragon Corporation on 'Accelerating industrial transformation and workers' skills development through worker cooperatives'.

Non-standard and undeclared work: what can cooperatives do?

Non-standard work remains a challenge across Europe, putting in jeopardy decent work opportunities, the social protection of workers, and the occupational health and safety of workers. Worker and social cooperatives across Europe have therefore developed successful models to fight this phenomenon, and to uphold the rights of vulnerable workers. In 2021, CECOP has dedicated several activities to promote the role of worker and social cooperatives in this field.



LIGHTS ON! Worker and social cooperatives tackling undeclared work

Focusing on the qualitative analysis of 11 European cooperatives, the <u>LIGHTS ON publication</u> explores how the cooperative model can offer concrete solutions to support the transition of undeclared workers into the formal economy within the European context.

The report was promoted during an <u>online event</u> witnessing the participation of national actors, the ILO, ELA, and ETUC as a tool to promote a better understanding of the potential of cooperatives in tackling undeclared work.

The work was also promoted through a <u>docuseries</u> that, throughout four episodes, highlighted key findings of the report and showcased cooperatives on the ground fighting undeclared work.

Platform cooperatives: an example of quality and democracy

Many platform workers are misclassified as self-employed, meaning they do not have access to social protection and are denied basic workers' rights. Moreover, they are often dependent on the untransparent digital management of investor-driven capitalistic platforms. In 2021, CECOP <u>welcomed</u> the Platform Work Directive proposal of the European Commission to put an end to the misuse and abuse of platform workers' employment status and dependence on algorithms.

CECOP members' working group on nonstandard employment and platform work

In 2021, the CECOP members' working group on non-standard employment and platform work focused on <u>advocating for the recognition of platform cooperatives</u> by the European institutions and highlighting the potential of cooperatives to improve working conditions in the platform economy. Over the last years, CECOP and its members gained substantial experience in addressing the needs of platform workers, developing cooperative solutions to the challenges of the platform economy, and improving working conditions for platform workers. The cooperative solution for platform work has been acknowledged also by the <u>European Parliament</u> and the <u>European Economic and Social Committee</u>.



European Pillar of Social Rights: a cooperative priority

Unequal access to employment, education, social services reinforce and deepen existing inequalities. Worker and social cooperatives <u>play a crucial role</u> in fighting the causes of these inequalities across Europe by providing quality work and social inclusion opportunities. CECOP brings forward the advantages of the entrepreneurial model of worker and social cooperatives for youth, women, people with disabilities, migrants, and any other vulnerable category at risk of social exclusion.

Workshop on the Future of EU Disability Strategy

The workshop, organized by CECOP in collaboration with its Portuguese member, ConfeCoop, on the <u>Future of the EU Disability Strategy</u> provided valuable insights on how worker and social cooperatives ensure the rights of persons with disabilities and offered supportive recommendations for national and European policymakers on the new EU Disability Strategy.



CECOP at Cooperatives' Europe workshop on post COVID recovery and Gender Equality

CECOP accentuated the role that cooperatives can play in providing better entrepreneurial opportunities to women, even in times of crisis, compared to traditional enterprises, during the workshop on post COVID recovery and gender equality organized by Cooperatives Europe.



CECOP at the Civil Society Days

Organized by the European Economic and Social Committee (EESC), the Civil Society Days are a public forum, bringing together civil society organizations, European citizens, and European institutions. In 2021, CECOP took part in the roundtable "Social Economy and youth entrepreneurship for a sustainable recovery" highlighting the role of cooperatives in job creation, in particular for young people.





Projects



4-year partnership agreement with the European Commission under the EaSI programme

CECOP signed a <u>four-year-partnership agreement</u> (2018 – 2021) with DG Employment, Social Affairs and Inclusion, financed by the EaSI programme for Employment and Social Innovation (EaSI) supporting EU-level NGO networks active in the areas of social inclusion and poverty reduction.

The EaSI activities in 2021 included:



Two analyses

- Impact of the COVID-19 outbreak on cooperatives in industry and services:
 Information was gathered all year long through different channels (discussions with members, statutory meetings, analysis of members' reports).
 Lessons learned from the COVID crisis.
- Analysis of data on cooperatives contributing to social inclusion: In collaboration with its Italian and Spanish members, CECOP collected qualitative and quantitative information on the positive social impact of worker and social cooperatives on the communities they operate in, their workers, and their beneficiaries.



Two publications

- <u>LIGHTS ON! Report:</u> On worker and social cooperatives' contribution to the transition from the informal to the formal economy. Available also in Italian and Spanish.
- <u>Lasting Impact Report:</u> On measuring the social impact of worker and social cooperatives in Europe: focus on Italy and Spain, was published displaying two best practices of social impact measurement among cooperatives and the outcomes on the data analyzed about the cooperatives' social impact in Italy and Spain.


CECOP's main work is to promote the worker and social cooperative model among the EU institutions, European cooperative organizations, and the external public.



About CECOP

CECOP is the European confederation of industrial and service cooperatives. It represents the voices of worker cooperatives, social cooperatives, and independent workers' cooperatives. CECOP works to create a supportive environment for cooperatives, so that they can operate to their full strength and fulfil their mission of providing sustainable jobs and high-quality services to communities.
