WORKER AND SOCIAL COOPERATIVES REINFORCE SOCIAL EUROPE THROUGH DEMOCRATIC QUALITY WORK AND SOCIAL INCLUSION

CECOP reacts to a European Commission consultation on the European Pillar of Social Rights Action Plan, highlighting the crucial role worker and social cooperatives take to ensure the protection of social rights of their members by providing quality work and social inclusion.

In its 2021 work plan, the European Commission announced an action plan to implement the European Pillar of Social Rights. In light of the green and digital transitions, but also the demographic challenges across Europe, the European Pillar of Social Rights is a key building block to ensure socially fair and inclusive economies and societies.

CECOP FLAGSHIP CONFERENCE AND CAMPAIGN ON COOPERATIVE RESPONSES TO NON-STANDARD AND PLATFORM WORK

Worker-owned cooperatives have developed effective strategies to react to the challenges of non-standard work, a CECOP <u>report</u> found in 2019. To disseminate and discuss the findings of this report, CECOP launched a <u>communication campaign</u> that finished with an online conference on 3rd December.

To promote the responses of worker-owned cooperatives to non-standard work, CECOP published a series of videos, featuring the Lillith Cooperative in Finland, an interview with Francesca Martinelli of Doc Servizi Foundation, and a statement by CECOP president Giuseppe Guerini.

The conference featured different perspectives and speakers, from practitioners, researchers and policy makers. "Organizing in cooperatives gives greater strength to workers, it helps to mutualize needs and risks, and provides mutual aid and solidarity. But above all, it allows to redefine the identity of workers and give meaning and dignity in their work", CECOP President Giuseppe Guerini highlighted.

05 CECOP REACTS TO PRESIDENT VON DER LEYEN'S STATE OF THE EUROPEAN UNION ADDRESS

On September 16th, 2020 Commission President von der Leyen gave her first state of the European Union address in the European Parliament. CECOP welcomes the ambitions of the Commission to tackle the dual green and digital transitions but urges the EU to better promote the diversity of European enterprise models.

CECOP's Secretary General, Diana Dovgan, welcomed the focus on the green and digital transitions in Europe: "The efforts to support businesses to transforming to climate-compatible business models and to harnessing the benefits of digitalization are both needed and timely, especially during this

unprecedented crisis. However, both crisis support measures and transition programmes must not overlook the importance and needs of cooperatives in industry and services, as well as the broader social economy."

Last September marked the conclusion of the EMEN (European Migrant Entrepreneurship Network) project, which started in 2017. Over the course of three years, the network brought together 12 partners and over 150 organizations working on migrant entrepreneurship. CECOP congratulates its partners on the successful conclusion of this important project and is looking forward to the exciting work of the project partners in the future.

During the <u>final conference</u> of the Project, CECOP President Giuseppe Guerini highlighted the importance of worker and social cooperatives and the social economy in the inclusion of vulnerable groups in our societies. Cooperatives and social economy enterprises, based on active and democratic participation, facilitate equal access to services and work opportunities for disadvantaged groups, such as migrants and refugees. By providing work and ensuring access to social services, they not only allow successful inclusion but foster a life in dignity.

CECOP, <u>Diesis Network</u>, and <u>REVES</u> contributed to the final report "Inclusive Ecosystems: towards a comprehensive support scheme for migrant entrepreneurs in Europe" with a chapter on "Social Economy and Social Entrepreneurship: the role of social economy enterprises in supporting migrant entrepreneurs", which analyses the support that social economy gives to migrant entrepreneurship.

with disabilities across Europe. Among these best practices, two cooperatives that are affiliated with CECOP members are highlighted: <u>Adelante Dolmen</u> in Italy, and <u>TPK Mara Dencheva</u> in Bulgaria.

CECOP congratulates Social Economy Europe on the publication and both cooperatives for being featured as best practices. Supporting the integration and full inclusion of people with disabilities through work or by providing services is one of our core missions.

CECOP SUPPORTS THE CALL FOR AN ADEQUATE AND ACCESSIBLE MINIMUM INCOME

CECOP joined the call of the European Trade Union Confederation, Eurodiaconia, Caritas Europe, the Social Platform and the European Anti-Poverty Network in their call for an EU Framework Directive enabling an adequate and accessible Minimum Income.

One in five Europeans is at risk of poverty and social exclusion. Almost 110 million people across Europe struggle to make ends need and live a life in dignity, with the recent pandemic likely to increase this number. It is therefore high time to take action and ensure an adequate minimum income across Europe.
