## CECOP PROPOSALS FOR THE EUROPEAN SOCIAL ECONOMY ACTION PLAN

CECOP reacted to the European Commission's consultation on the Social Economy Action Plan, calling to recognise worker and social cooperatives as an integral part of the Social Economy.

The European Social Economy Action Plan is a crucial step to build a sustainable, inclusive, and social Europe. The European Green Deal strives to leave no person and no place behind, and the European Pillar of Social Rights sets out to build a strong Social Europe. The Social Economy is a cornerstone for delivering these goals to the people of Europe.

The European Commission launched its first stage social partners consultation on improving the working conditions in platform work. CECOP welcomes the analysis brought forward by the EC and the consultation with European social partners, furthermore it supports a European legislative approach of the new Platform Work Initiative and highlights the important role that cooperatives are playing and could further play in the platform economy with specific regards to the creation of quality and democratic jobs.


