I. Background

III. Scope of the work

In cooperation with the Secretary General and the Membership Coordinator, the selected candidate would help us develop a gender diversity/inclusion policy for the organisation. The gender diversity/inclusion policy should address the issue of diversity in the statutory bodies of the organisation, well-being at work for staff members, a code of conduct for events organized by CECOP, possibly training activities for CECOP's staff and members, and any other issue identified. In addition, the expert will help the organisation to assess the status of CECOP's members existing gender diversity/inclusion policies.

The gender diversity/inclusion policy would enhance CECOP to achieve equal opportunities and treatment in its statutory bodies and at the workplace.

IV. Tasks

The consultant/external expert will have the following tasks:

- analyse organisation's needs and existing tools
- establish a methodology for developing a gender diversity/inclusion policy
- draft a diversity and inclusion policy for CECOP
- conduct internal training sessions associated with the above tasks
- mapping of CECOP's members existing gender diversity/inclusion policy
